**2009** 

Enters into the hospitality industry by signing a voice and data agreement with Extended Stay Hotels

**2011** 

Velocity is awarded a trademark for V-SELECT™

Grows to 50 employees

**2014** 

Begins repairing electronic devices and commercial photo printers for large retailers

**2019** 

Establishes a Digital Signage and Media division entering into the Advertising and Entertainment Industry

Grows to 500 employees

**2020** 

Velocity rebrands and changes its name to: Velocity, A Managed Services Company, Inc.

Velocity begins servicing the motion picture industry through a strategic partnership, "MVP" (Metamedia, Velocity, Pixelogic), to deliver digital content creation and distribution services to theaters

Enters into a joint venture with Paper Airplane to further strengthen its position in servicing the motion picture industry

**Enters into a joint venture with IMOXIEMEDIA** providing marketing distribution services to the entertainment and consumer products industries

**Acquires CTI Solutions** to strengthen Velocity's in-house development capabilities of SaaS products for high-end digital media and content management solutions


